## News From the Heart Institute

**Andrew Redington, MD**, joined the Heart Institute in November as the chief of Pediatric Cardiology and executive co-director of the Heart Institute. He is also appointed as professor of Pediatrics, University of Cincinnati. Below is a recent interview with Dr. Redington, regarding his background and impressions and visions for the Heart Institute.

### **Andrew Redington Sees Bright Future for the Heart Institute**

“I can’t stand average. We are better than that.”

So says **Andrew Redington, MD**, the Heart Institute’s new executive co-director. Redington sets the bar high when it comes to patient care, but he doesn’t ask anything of others that he doesn’t require from himself. Since his arrival in November, he’s attended countless meetings to observe, listen and get to know his colleagues.

“There’s a huge amount of talent here,” he says, “and a real sense of ambition. Our challenge is to harness that and make the Heart Institute better than it’s ever been.”

Redington was born, raised and educated in London in the United Kingdom. Becoming a doctor wasn’t originally on his radar screen. “I didn’t come from a medical family. I fell into it, really,” he explains. “I was quite good at science, so I decided to go to medical school. Initially I thought I would be an adult intensivist, but then I became interested in adult cardiology. It went very well, and I was promoted to a research position. That’s when I got seduced by pediatrics.”

He signed on for six months’ training in neonatal cardiology at the University College of London, followed by another round of training in renal pediatrics at Great Ormond Street. Then he worked as the senior registrar (the only fellow!) at the Royal Brompton Hospital in South Kensington.

“The program at Brompton was outstanding,” says Redington. “It was a small children’s heart and lung center inside an adult heart and lung center. I was surrounded by top adult cardiologists and some of Europe’s leading academic pediatric cardiologists. Even back in the late 1980s, the annual mortality rate was 3 percent – one-third of the prevailing rate across the country. It was an incredibly dynamic, exciting place to be, with an aggressive but powerful sort of atmosphere.” Over the course of his career, Redington went from being a “Brompton boy” to practicing at Great Ormond Street – the largest children’s hospital in the United Kingdom. In 2001, the Hospital for Sick Children in Toronto offered him “the best job in the world.” Nonetheless, Redington might have finished out a comfortable career there. But when Cincinnati Children’s contacted him about co-directing the Heart Institute in 2013, he was intrigued. “There are very few jobs I would have left Toronto for,” he admits. “But the people in the Heart Institute impressed and inspired me. They have the talent and the desire to be the best. But they also have the resources to make it happen, including the support of hospital leadership, which is excellent.”

### **Life-Altering Experience**

Redington has distinguished himself as a premiere pediatric cardiologist and researcher, but his most humbling learning experience came when his daughter was born at 26 weeks’ gestation, weighing a mere 680 grams (nearly 1 lb, 8 oz). “Her birth and hospitalization were *the* most important few months of my career,” he says. “It was unbelievably eye-opening to be on the other side of the interaction with the doctors. I learned a great deal about what parents want, how they read so much into what a doctor says or doesn’t say. They latch onto little things – tone of voice, a facial expression – and feel reassured or frightened until the next consultation. During that time, I saw the best and worst of care.”

Redington’s little girl has grown up to be a physician herself, but that experience is what drives him to set the bar so high for himself and his team. “I am dedicated to optimal clinical care first and foremost,” he says. “Very few things make me angry, but if patient care suffers because of laziness, arrogance or self-importance, or because a system is flawed, that is unacceptable. We have to provide the ultimate clinical care before anything else becomes relevant – the research, the innovations and the practice changes.”

### What's Next

As Redington settles into his new role, he has his eye on ways the Heart Institute can get even better.

Redington envisions tweaking the Heart Institute environment to allow for more integration and collaboration between the sub-specialties. He sees huge opportunities for translational and transformational research and discovery, and the way the Heart Institute Research Core plays a role in supporting the highest quality research output will also be important. He also looks forward to improving efficiencies and fostering the ideas of faculty and fellows.

“Ultimately, what will differentiate us in the world is if we are able to change practice, to be thought-leaders within our specialty,” he says. For example, “right now, there are 600,000 adults with significant congenital heart disease who need a specialist’s care. Less than 10 percent find their way to an adult congenital heart center after age 18. These are people we have followed since birth. It is our responsibility to make sure they have access to appropriate care. As we look towards the next 10 years of development of Cincinnati Children’s and the Heart Institute, we have to look at a paradigm change in the way we deliver care for our patients of all ages. If we don’t do it, who will?”

He adds, “I’m an optimist at heart. We have an extraordinary team, so I find myself going home at night, thinking, ‘My God, this might actually work!’ There’s incredible potential here and very little to stop us from fulfilling it.”
