CINCINNATI - If doctors say your newborn baby needs complicated heart surgery, you'll likely be flooded with emotions and questions.

Now, to assist surgeons and to help parents understand what is happening, doctors at Cincinnati Children's Hospital Medical Center are using advanced imaging technology to create three-dimensional models of their little patients' hearts.

"Our families have loved having the ability to see what their kids' hearts and what their babies' hearts look like," said Dr. Ryan Moore, "especially during the process when the surgeon is talking to them about the procedure, because it really helps them to understand exactly what we're going to do."

Moore is an pediatric cardiology fellow at the Heart Institute at Cincinnati Children's. With a team of specialists, he creates 3-D heart models for patients ranging in age from newborn to adult. "The 3-D model should be an exact representation of the imaging data that we get," said Moore.

In addition to helping doctors communicate with families, Moore said the heart model serves as an important tool to help cardiologists prepare for complex surgeries that call for meticulous attention to detail. "You can hold it, and it allows our surgeons to kind of get a good understanding in every view possible about what the patient's heart looks like."

Children's-UC joint effort

To create 3-D heart models, Children's collaborates with the University of Cincinnati College of Engineering and Applied Science.

First, Children's doctors perform either a cardiac CT (computed tomography) or MRI (magnetic resonance imaging) scan on the patient's heart. "That imaging information is then transferred into a computer software, where we build the model as a virtual model, and then from there the virtual model is sent to the printer," said Moore.

A special printer at UC's College of Engineering and Applied Science builds the model, laying down the material, layer by layer. It's a technique called 3-D printing.

"[Three-dimensional] printing is actually a technology that is very similar to a desktop printer that prints out with ink on a paper, but, instead of using ink, it's using plastic. It's building, layer by layer, the model," explained Moore. "And as the plastic is built, there is UV light that cures it and makes it into this hard material."

Prepping for surgery

To help doctors prepare for complex surgery, the models can be created with a clear, plastic material that mimics the feel of actual heart tissue. "We can make a model that's a little softer and flexible, and we can actually put catheters in it and plan surgeries off of it," said Moore.

Doctors can even cut into the heart model and see through the various structures, highlighting defects and issues that they might encounter during surgery.

Pitter Patter of Little Hearts . . .

Using a 3-D heart model, doctors can see anomalies including:

- Internal and external heart defects.
- Twisted vessels.
- Blood clots.
- Narrowings.
- Tumors.

The technology doesn't apply just to children. Last month, Children's Hospital specialists used a 3-D heart replica to plan a complex surgery for a 31-year-old Anderson Township man.

Damon Mallot was first treated for heart problems at Children's as a newborn. Recently, he developed heart rhythm abnormalities and blood clots. Doctors performed a rare surgery to treat Mallot, and they say it went well.

"Because of the complexity of Damon's heart,... it was really good to have the actual model to practice on it and see what actually needs to be done," said Dr. Gruschen Veldtman, Mallot's cardiologist.

The specialists at Cincinnati Children's have created more than 20 3-D heart models during the last two and a half years. They will study the impact of the replicas on patient care.

"I think, in the future, we'll be able to see that this will improve outcomes and improve efficiency, and improve how long it takes for an operation to occur, but in the short term the things we've seen – we're just better about communicating," said Moore.

Meanwhile, worried parents appreciate the extra level of understanding a 3-D heart replica offers. "A lot of our families have been really emotional with this," Moore said, "and actually really enjoy the opportunity again to be able to hold their baby's heart in their hand."

We are grateful to Cindy Metz for table favors and to Sue Deye, Bev Rainier & Jeanine Wellbaum for yummy desserts.


